## **ADDENDUM**

The Government vide G.O.(D) No.46, Adi Dravidar and Tribal Welfare Department, dated 23.09.2016 published the list of shortfall vacancies to be filled through Special Recruitment Drive. Further, the Government in Adi Dravidar and Tribal Welfare Department in the D.O. letter No.15588/TD-2/2016-11, dated 05.10.2018 furnished the shortfall vacancies in the category 'C' posts. As per the orders of the Hon'ble High Court of Madras in W.P.No.2937 of 2018, dated 10.10.2018, the following vacancies received from the unit officer / HOD for the posts included in Combined Civil Services Examination – IV (Group-IV and Village Administrative Officer) have been added to the Notification No.23/2017, dated 14.11.2017 subject to the confirmation to be received in regard to the number of Shortfall vacancies(SC/ST) from the Government. The written examination for these posts was held on 11.02.2018.

Further, in a Direct recruitment process for selection against current / regular vacancies and shortfall vacancies, the selection shall be made in the following order and naturally the seniority among them will also be in the same order.

- 1. First, the selection will be made for regular vacancies following the rule of reservation.
- 2. Next, the selection for shortfall vacancies will be made from among the SC / ST applicants only.
- 3. The reservation for Women, Differently Abled Persons and Ex-Servicemen etc will not be applicable for the recruitment of shortfall vacancies (Section 27(h) of Tamil Nadu Government Servants (Conditions of Service) Act, 2016).
