- 1. After Onscreen Certificate Verification, the list of eligible candidates for Oral Test will be published subsequently in the ratio of 1:2/1:3.**
- 2. Mere inclusion of the register number of the candidates does not imply that their candidature has been fully considered for next stage of selection.**
3. The candidates whose register numbers are found in the above list have been provisionally admitted to the Onscreen Certificate Verification based on the marks obtained by them in the examination (Computer Based Test) and with reference to the rule of reservation of appointments.
4. The admission of candidates to the Onscreen Certificate Verification is provisional subject to verification and acceptance of claims as made in their respective online applications with regard to Age, Educational Qualification, Communal category, Differently Abled category and PSTM etc., through original documents. If any of the candidate's claims are found to be false or incorrect, their online applications will be rejected and their provisional admission

to Onscreen Certificate Verification will be cancelled and they will not be admitted to the next stage of selection.

5. The admission of the above candidates to the Onscreen Certificate Verification is purely provisional subject to the final orders to be passed in W.P.Nos.28969 and 28973 of 2022, W.A.Nos.2475 and 2476 of 2022 and other cases, if any, pending on the files of the Hon'ble High Court of Judicature at Madras/Madurai Bench of Madras High Court, relating to this recruitment.
