DEPARTMENT INCLUDED IN THE TAMIL NADU JAIL SERVICE

The list of register numbers of candidates admitted provisionally to onscreen certificate verification for the post of **PSYCHOLOGIST** in Prisons and Correctional Services Department included in the Tamil Nadu Jail Service, in the ratio of 1:4, was published on the Commission's website on 12.10.2022 based on the results of the computer based test conducted by the Commission on 06.08.2022 FN & AN.

Based on the outcome of onscreen certificate verification, the candidates whose register numbers mentioned below have been provisionally admitted to oral test in the ratio of 1:3 based on the marks obtained by the candidates in the computer based test and with reference to rule of reservation of appointments. The oral test will be held on **03.11.2022** at the office of the Tamil Nadu Public Service Commission, TNPSC Road, Chennai-600 003. The candidates should attend the oral test with all original certificates in support of the claims made in their online applications. The above details will be made available on the Commission's website and the candidates will be informed of the above fact only through SMS and e-mail accordingly. Individual communication regarding the date and time of oral test will not be sent to the candidates by post.

In the place of rejected candidates, candidate with the following register number is admitted to certificate verification and oral test and his/her admission to certificate verification and oral test is purely provisional subject to verification and acceptance of the documents in support of the claims made in his/her online application in respect of Age, Educational Qualification, PSTM status, Communal category, DA Status, Experience etc. Only after verification of the claims with the original certificates, his/her eligibility will become final for admission to oral test. If he/she does not produce the required certificates or if he/she does not satisfy the eligibility criteria, his/her online application will be rejected and his/her provisional admission to oral test will be cancelled and he/she will not be admitted to the next stage of selection process. Mere inclusion of the register number of candidate in the list does not confer any right on the part of candidate for participation in oral test.

- 1. Mere inclusion of the register numbers of candidates in the above list will not imply that his/her candidature has been fully considered for next stage of selection.**
2. The candidates whose register numbers are found in the above list have been admitted provisionally to the oral test/certificate verification and oral test based on the marks obtained by them in the computer based test and with reference to rule of reservation of appointments.
3. The admission of candidates to the oral test/certificate verification and oral test is provisional subject to verification and acceptance of the claims in their online applications towards Age,

Educational Qualification, Community, Ex-servicemen Status, PSTM status, Experience etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to oral test /certificate verification and oral test will be cancelled and they will not be admitted to next stage of selection.

4. The candidates who have appeared for computer based test and whose register numbers are not found in the above list have not been admitted to the oral test / certificate verification and oral test.
5. The admission of the above candidates to the oral test/ certificate verification and oral test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.
6. Candidates who have been admitted provisionally to the oral test /certificate verification and oral test are hereby advised to attend the oral test with all the relevant documents, in original without fail. Failure to produce even any one of the essential documents will result in their non-admission to the next stage of selection.
7. The list of register numbers of candidates who were admitted to onscreen certificate verification and who have not been considered for provisional admission to oral test/certificate verification and oral test and the reasons therefor have been mentioned in the Annexure to this list.
