

## POST OF HOSTEL SUPERINTENDENT CUM PHYSICAL TRAINING OFFICER IN TAMIL NADU EMPLOYMENT AND TRAINING SUBORDINATE SERVICES

If he/she does not produce the required certificates or if he/she does not satisfy the eligibility criteria, his/her online application will be rejected and his/her provisional admission to Physical Certificate Verification will be cancelled.
