They should upload the scanned copy of documents in support of the claims made in their online application from **04.10.2021** to **12.10.2021** in the e-seva centres run by TACTV. The details regarding the documents to be uploaded will be made available in the Commission's website and candidates will be informed of the above fact only through SMS and E-mail. Individual communication in this regard will NOT be sent to the candidates by post.

4. The admission of the above candidates to the Onscreen Certificate Verification is purely provisional subject to the decision of the Commission and subject to the outcome of final orders to be

passed by the Hon'ble High Court of Judicature at Madras in the WP No.26213 of 2019 and W.M.P.No.25593 of 2019 and other cases relating to this recruitment, if any, pending on the files of the Hon'ble High Court, Madras / Madurai Bench of Madras High Court.

5. Candidates who have been admitted provisionally to the Onscreen Certificate Verification are hereby advised to upload the scanned copy of all the relevant documents without fail. Failure to upload even any one of the essential documents within the time limit stipulated above will result in their non-admission to the next stage of selection and rejection of their online application.
