A list of 16 candidates provisionally admitted to Certificate Verification for Oral Test for appointment by direct recruitment to the posts of **Tester (2014-2016) and Assistant Tester (2013-2014) in the Tamil Nadu Industries Subordinate Service** was published in the Commission's website on 01.02.2017 based on the results of the written examination conducted by the Commission on 25.06.2016 FN & AN.

During the Certificate Verification held on 09.02.2017, 1 candidate had absented himself, the application of 1 candidate has been subsequently rejected and the eligibility status of 1 candidate has changed.

Notes:-

1. Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for Oral Test.

2. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Certificate Verification to verify the eligibility for admission to Oral Test based on the marks obtained by them in the Written Examination and with reference to rule of reservation of appointments. The admission of candidates to Certificate Verification is provisional subject to verification and acceptance of the claim in their online applications towards Age, Educational Qualification, Community, Experience etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Certificate Verification will be cancelled and they will not be admitted to Oral Test.
3. The admission of the above candidates to the Certificate Verification is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.
4. Candidates who have been admitted provisionally to the Certificate Verification are hereby advised to attend the Certificate Verification with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the next Stage of Selection.
