Individual intimation regarding the date and time of Physical Certificate Verification (PCV) and Counselling will be informed through Commission's website, SMS and e-mail only. No individual intimation will be sent to the candidates by post. The admission to Physical Certificate Verification (PCV) and Counselling is purely provisional subject to verification and acceptance of the original documents in support of all the claims made in the online application in respect of Age, Gender, Communal Category, Educational Qualification, Experience, etc. Only after verification of all the claims with the original certificates, the eligibility of such candidates will become final for admission to Counselling. If he/she does not produce the required certificates or if he/she

does not satisfy the eligibility criteria, his/her online application will be rejected and his/her provisional admission to Physical Certificate Verification (PCV) and Counselling will be cancelled.

Notes:

1. Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for Physical Certificate Verification and Counselling.
2. The candidates whose Register Numbers are mentioned in the above list have been admitted provisionally to PCV and Counselling based on the particulars furnished by them in their online application, mark and overall rank obtained by them in the written examination and with reference to the rule of reservation of appointments and number of vacancies.
3. The candidates who had appeared for written examination on 18.12.2022 FN & AN and their Register Numbers are not found in the above list have not been admitted to the Physical Certificate Verification and Counselling for the said posts.
4. After verification of original documents, the eligible candidates alone will be admitted for counselling to be held on the same day itself.
5. The candidates can download their Memorandum for Admission from the Commission's Website and should attend the Certificate Verification and Counselling with all the relevant documents in original on the prescribed date and time without fail.
6. Candidates who have failed to attend PCV and Counselling on the scheduled date and time will not be considered for the next stage of selection.
7. The provisional admission of the candidates to PCV and Counselling does not confer any right for selection and their selection will also be subject to availability of vacancies in their respective reservation categories, when they reach their turn as per their rank position.
8. The admission of above candidates for PCV and Counselling is purely provisional subject to the outcome of writ petitions, if any, pending on the files of the Hon'ble High Court of Madras / Madurai Bench of Madras High Court relating to this recruitment.
