**TOURIST OFFICER IN THE TAMIL NADU
GENERAL SERVICE, 2014-2015**

Three lists of Register Numbers of candidates provisionally admitted to Certificate Verification for the post of **Tourist Officer in the Tamil Nadu General Service, 2014 – 2015** were published in the Commission's website on 11.07.2018, 21.08.2018 and 03.10.2018 based on the results of the Main Written Examination conducted by the Commission on 09.09.2017 FN, 09.09.2017 AN and 10.09.2017 FN.

After the 1st, 2nd and 3rd phases of Certificate Verification held on 18.07.2018, 31.08.2018 and 15.10.2018 respectively, the candidates whose Register Numbers are mentioned below have been provisionally admitted to Oral Test in the ratio of 1:3. The Oral Test will be held on **02.11.2018** at the office of the Tamil Nadu Public Service Commission, TNPSC Road, Chennai - 600 003. The candidates should attend the Oral Test with all original certificates in support of the claims made in their online applications. **Individual Communication regarding the date and time of Oral Test will not be sent to the candidates by post. The above details will be made available in the Commission's Website and Candidates will be informed of the above fact only through SMS and e-mail accordingly.**

If any of their claims are found to be false or incorrect, their provisional admission to Oral Test will be cancelled.
3. The candidates who have appeared for the Main Written Examination and whose register numbers are not found in the above list have not been admitted to the Oral Test.

The admission of the above candidates to the Oral Test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.
5. Candidates who have been admitted provisionally to the Oral Test are hereby advised to attend the Oral Test with all the relevant documents in original, without fail. Failure to produce even any one of the essential documents will result in their non-admission to the Oral Test.
