ORDER:

The Secretary, Tamil Nadu Public Service Commission, in his letter first read above has stated that the 28th Equivalence Committee has resolved in Resolution No.5, that the Master of Labour Management (MLM) Degree Course awarded by Madurai Kamaraj University and P.G. Honours Diploma in Personnel Management and Industrial Relations awarded by Madras School of Social Work as equivalent to the Master of Labour Management (MLM) awarded by the Tamil Nadu Institute of Labour Studies, Chennai and as equivalent to Post Graduate Diploma in Personnel Management and Industrial Relations and Labour Welfare awarded by the Madras Productivity Council (or) Post Graduate Diploma in Personnel Management and Industrial Relations awarded by the Madurai Institute of Social Work, Madurai for the Post of Labour Officer in the Tamil Nadu Labour Service and has requested the Government to issue necessary orders and to communicate a copy of the order to Tamil Nadu Public Service Commission.

2. In the letter second and third read above, the Secretary, Tamil Nadu Public Service Commission has stated that, in the 39th Equivalence Committee meeting held on 8.3.2013, the Committee has passed, amongst others, Resolution No. 4, that "Degree in Sociology is considered equivalent to a degree in Social Science for the purpose of recruitment to the post of Labour Officer".

3. The Government after careful examination, accept the resolutions of the 28th and 39th Equivalence Committee of the Tamil Nadu Public Service Commission and accordingly orders the following educational qualifications as

equivalent to the education qualifications prescribed to the post of Labour Officer for direct recruitment in the Tamil Nadu Labour Service :-

- (i) Degree of M.A., Labour Management (formerly known as MLM) Course awarded by Madurai Kamaraj University and P.G. Honours Diploma in Personnel Management and Industrial Relations awarded by Madras School of Social Work are equivalent to M.A., Labour Management (formerly known as the MLM) awarded by the Tamil Nadu Institute of Labour Studies, Chennai and equivalent to Post Graduate Diploma in Personnel Management and Industrial Relations and Labour Welfare awarded by the Madras Productivity Council (or) Post Graduate Diploma in Personnel Management and Industrial Relations awarded by the Madurai Institute of Social Work, Madurai for the post of Labour Officer in the Tamil Nadu Labour Service.
- (ii) Degree in Sociology is considered equivalent to a degree in Social Science for the purpose of recruitment to the post of Labour Officer.
