EXAMINATION, 2012-2013, 2015-2016 & 2016-2017**

The list of Register numbers of candidates provisionally admitted to 1st phase of Certificate Verification for the **POSTS INCLUDED IN THE COMBINED ENGINEERING SERVICES EXAMINATION, 2012-2013, 2015-2016 & 2016-2017** was published in the Commission's website on 23.07.2018 based on the results of the written examination conducted by the Commission on 24.02.2018 FN & AN.

The candidates were asked to upload the certificates from 01.08.2018 to 10.08.2018. After the last date, the certificates uploaded by the candidates were verified and the applications of 59 candidates were rejected including 23 candidates who had not uploaded the certificates within the stipulated time limit. It has therefore been decided to admit the candidates to the next phase of Certificate Verification in the ratio of 1:5 in the place of the said 59 candidates.

Hence, apart from the candidates in respect of whom the certificates have been verified, the candidates with the following register numbers are hereby admitted provisionally to the certificate verification for the said posts. They should upload the scanned copy of documents in support of the claims made in their online application from **04.10.2018** to **17.10.2018** in the e-seva centres run by TACTV. A List of designated e-seva centres is available in the Commission's website. The details regarding the documents to be uploaded will be made available in the Commission's website and candidates will be informed of the above fact only through SMS and e-mail. Individual communication in this regard will NOT be sent to the candidates by post.

Notes: -

1. **Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for next stage of selection.**
2. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Certificate Verification based on the marks obtained by them in the Written Examination. The admission of candidates to Certificate Verification is provisional subject to verification and acceptance of the claim in their online applications towards Age, Educational Qualification, Community, Differently Abled, PSTM, Practical Training etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Certificate Verification will be cancelled and they will not be admitted to the next stage of selection.
3. The admission of the above candidates to the Certificate Verification is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WP Nos. 16206, 16207 of 2018 and 16273 of 2018 and other WMPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.

4. Candidates who have been admitted provisionally to the Certificate Verification are hereby advised to upload the scanned copy of all the relevant documents without fail. Failure to upload even any one of the essential document will result in their non-admission to the next stage of selection.
