1. Mere inclusion of the Register Numbers of candidates will not imply that their candidature has been fully considered for next stage of selection.

The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Oral Test based on the marks obtained by them in the Written Examination and with reference to the Commission's Notification No.07/2019 dated 28.01.2019 which has been notified as per the orders of the Hon'ble High Court of Judicature at Madras in WP No. 2937/2018, Cont. P.No. 1773/2015 and WMP No. 3599/2018.
3. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Oral Test based on the marks obtained by them in the Written Examination. The admission of candidates to Oral Test is provisional subject to verification and acceptance of the claim in their online applications towards Age, Educational Qualification, Communal Category etc., through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Oral Test will be cancelled and they will not be admitted to the next stage of selection.
4. The candidates who have appeared for Written Examination and whose register numbers are not found in the above list have not been admitted to the Oral Test.

The admission of the above candidates to the Oral Test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.
6. Candidates who have been admitted provisionally to the Oral Test are hereby advised to attend the Oral Test with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the Oral Test.
