ORDER:

RThe Registrar, Alagappa University has requested the Government to recognise the course M.A. Corporate Secretaryship' now renamed as "Master of Corporate Secretaryship" offered by Alagappa University, Karaikudi on par with other Post Graduate Degrees like M.A., H.Com., and M.B.A., for the purpose of employment in public services.

2. The request of the Registrar, Alagappa University has been referred to the Committee constituted for the purpose in G.O.Ms.No.441, Personnel and administrative Reforms Department, dated 20.12.93 for its recommendation.

3. The Secretary, Tamil Nadu Public Service Commission, has stated that the Committee at its meeting held on 14.12.94 resolved to recommend to the Rovernment for recognition of the course "Master of Corporate Secretaryship" offered by Alagappa University as a Post Graduate Degree and not as equivalent M.B.A.Dogree for the purpose of employment in public services.

4. The Government after careful examination of the request for recognition and the recommendation of the Committee have decided to accept the recommendation of the Committee and accordingly direct that the course of "Master of Corporate Secretaryship" offered by Alagappa University be recognised for purpose of employment in public services. The Government also direct that "Master of Corporate Secretaryship" be recognised only as a Post Graduate Degree and not as equivalent to M.B.A. Degree for employment purposes.
