The Registrar of the Anna University in his letter first read above has requested the Government to recognise the following M.Sc., Degree courses offered by the Anna University as equivalent to the Post Graduate Degrees mentioned against each for the purpose of appointment to the teaching post in Higher Secondary Schools, and Colleges for which a M.Sc., Degree in Mathematics/ Physics/Chemistry is prescribed and also to the posts where a mere Post Graduate Degree without reference to the subject is prescribed:-

1. M.Sc., Applied Mathematics M.Sc., (Mathematics)

2. M.Sc., Material Science

3. M.Sc., Medical Physics M.Sc., (Physics)

M.Sc., (Physics) 4. M.Sc., Applied Chemistry M.Sc. Chemistry.

2. The Tanil Nadu Public Service Commission, when Consulted, has stated that the M.Sc., (Applied Maths) and M.Sc., (Material Science) may be considered as equivalent to M.Sc. (Maths) and M.Sc. (Physics) respectively for doing research leading Moster of Philosophy, Doctor of Philosophy in Engineering Physics and for teaching up to +2 level only. The Committee

constituted in the G.O.third read above has also recommended the Government to treat the M.Sc. (Applied Mathematics) and M.Sc. (Material Science) of the Anna University as equivalent of M.Sc. (Maths)/M.Sc. (physics) respectively.

3. The Government after careful examination accept views of the Tamil Nadu Public Service Commission and the recommendation of the committee as indicated in para 2 about that the degree of M.Sc. (Applied Mathematics) of M.Sc. (Material Science) offered by Anna University, Madras recognised as equivalent to M.Sc. (Maths) and M.Sc. (Physics) Poctor of Philosophy in Engineering Physics and for teaching upto Higher Secondary level only.
