Three lists of Register Numbers of candidates provisionally admitted to Certificate Verification for the posts of **AUTOMOBILE ENGINEER IN THE MOTOR VEHICLES MAINTENANCE DEPARTMENT (2013-14) AND AUTOMOBILE ENGINEER IN THE POLICE TRANSPORT WORKSHOP-CUM-TRAINING SCHOOL, AVADI AND REGIONAL POLICE TRANSPORT WORKSHOP, TIRUCHIRAPPALLI (2014-15) IN THE TAMIL NADU GENERAL SERVICE** were published in the Commission's website on 09.11.2017, 25.01.2018 and 19.06.2018 based on the results of the Written Examination conducted by the Commission on 20.08.2017 FN & AN.

During the 1st, 2nd & 3rd phases of Certificate Verification held on 17.11.2017, 09.02.2018 and 29.06.2018, 6 candidates had absented themselves, the applications of 16 candidates were rejected and the status of 2 candidates have changed. It has therefore been decided to admit the candidates to the next phase of Certificate Verification in the ratio of 1:5 against the categories which do not satisfy the ratio prescribed for admission to Oral Test.

Hence, apart from the candidates who had already completed the certificate verification, the candidates with the following register numbers are hereby admitted provisionally to the certificate verification for the said posts. The certificate verification will be held on **28.08.2018** at the office of the Tamil Nadu Public Service Commission, TNPSC Road, Chennai - 600003.

The candidates should attend the Certificate Verification with all original certificates in support of the claims made in their online applications. **Individual intimation regarding the date and time of Certificate Verification will not be sent to the candidates by post. The candidates will be informed through SMS and e-mail accordingly.**

After completion of Certificate Verification, the list for provisional admission to Oral Test in the ratio 1:3 will be published.

Notes:-

- 1. Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for next stage of selection.**
2. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Certificate Verification based on the marks obtained by them in the Written Examination and with reference to rule of reservation of appointments. The admission of candidates to Certificate Verification is provisional subject to verification and acceptance of the claim in their online applications towards Age, Educational Qualification, Community, Experience, PSTM etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Certificate Verification will be cancelled and they will not be admitted to the next stage of selection.
3. The admission of the above candidates to the Certificate Verification is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.
4. Candidates who have been admitted provisionally to the Certificate Verification are hereby advised to attend the Certificate Verification with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the next stage of selection.
