The above details will be made available in the Commission's website and the candidates will be informed of the above fact only through SMS and e-mail accordingly. Individual Communication regarding the date and time of Oral Test will not be sent to the candidates by post.

In the place of rejected candidates during certificate verification, a candidate with the following register number is admitted to certificate verification and oral test and his/her admission to **certificate verification and oral test** is purely provisional subject to verification and acceptance of the documents in support of the claims made in his/her online application in respect of Age, Educational Qualification, Communal category, Experience etc. Only after verification of the claims with the original certificates, his/her eligibility will become final for admission to oral test. If he/she does not produce the required certificates or if he/ she does not satisfy the eligibility criteria, his/ her online application will be rejected and his/ her provisional admission to oral test will be cancelled and he/she will not be admitted to the next stage of selection process. Mere inclusion of the Register Number of candidate in the list does not confer any right on the part of candidate for participation in Oral test.

The admission of the above candidates to the oral test/ certificate verification and oral test is purely provisional subject to the final orders to be passed in the WPs and other cases relating to this recruitment, if any pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court.

Candidates who have been admitted provisionally to the oral test/ certificate verification and oral test are hereby advised to attend the oral test with all the relevant documents, in original without fail. Failure to produce even any one of the essential documents will result in their non-admission to the next stage of selection.
