The candidates should come to office of the Tamil Nadu Public Service Commission with all original certificates in support of the claims made in their online applications. **Individual Communication regarding the date and time of Oral Test will not be sent to the candidates by post. The above details will be made available in the Commission's Website and Candidates will be informed of the above fact only through SMS and e-mail accordingly.**

5. Candidates who have been admitted provisionally to the Oral Test are hereby advised to attend the Oral Test with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the Oral Test.
