**ORDER:**

The President, Ambedkar World Federation of Employees Association, Chennai, has represented to the Government that the Column 1(b) and 1(c) of the proforma II in annexure V of G.O.Ms.No.368 P&AR (S) Dept. dated 18.10.93 prescribed for the preparation of the panel for promotion requires the description of the community name which is totally unwarranted. Though the column says that this is applicable only for the posts, which follow rule of reservation in promotion, spelling out the names of the castes, leads to biased treatment. He has therefore requested the Government to delete this column from the format and prescribe a column for mention of only SC/ST without mention of the specific community names as is being followed by the Government of India.

2. After Careful examination, the Government accepts the request of Ambedkar World Federation of Employee Associations to delete the Column (c) in Serial Number 1 prescribed in proforma II, Annexure V of G.O.Ms.No.368 Personnel & Administrative Reforms (S) Department dated:18.10.93. Accordingly, the following Amendments are issued to the Government order read above:-

**AMENDMENTS**

In the said Government order, in proforma II Contained in Annexure V, in serial number 1,-

- (1) Column (c) shall be omitted; and
- (2) in the sentence within bracket there under, for the expression "Column (b) and (c) are" the expression "Column(b) is" shall be substituted.
