1. Mere inclusion of the Register Numbers of candidates in the above list will not imply that his/her candidature has been fully considered for Original Certificate Verification/Counselling.
2. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Original Certificate Verification / Counselling based on the particulars furnished by them in their online application, Overall Rank obtained by them in the Written Examination and with reference to the Rule of reservation of appointments and Number of vacancies.
3. The candidates who have appeared for Written Examination on 01.09.2019 FN to the **Post of TYPIST INCLUDED IN COMBINED CIVIL SERVICES EXAMINATION-IV (GROUP-IV) for the years 2018-2019 and 2019-2020** and whose register numbers are not found in the above list have not been admitted to the Original Certificate Verification / Counselling for the said post.

4. The admission of candidates to the Original Certificate Verification / Counselling is provisional subject to verification and acceptance of their claim in their online applications such as Date of Birth, Gender, Community, Educational Qualification, Technical Qualification, PSTM, Differently Abled status etc., through Original documents. If any of their claims are found to be false or incorrect, their provisional admission to Original Certificate Verification will be cancelled and they will not be admitted to the Counseling.
5. After verification of Original Certificates, the eligible candidates alone are admitted for Counselling to be held on the same day itself.
6. The Candidates can download their Notice for admission to Original Certificate Verification / Counselling from the Commission's Website and should attend the Certificate Verification / Counselling with all the relevant documents in Original on the prescribed date and time without fail. Candidates who fail to attend Certificate Verification / Counselling on the scheduled date and time will not be considered for the next stage of selection.
7. The provisional admission of candidates to Original Certificate Verification / Counselling does not confer any right for selection and their selection will also be subject to availability of vacancies in their respective reservation categories, when they reach their turn as per their rank position and they are not assured of their selection.
8. The admission of candidates for Original Certificate Verification / Counselling is purely provisional subject to the outcome of WPs if any pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court relating to this recruitment.
