**Notes:-**

1. Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for original Certificate Verification / Counselling.
2. The candidates whose Register Numbers are found in the above list have been admitted provisionally in the ratio of 1:1.5 to the Original Certificate Verification and counselling based on the particulars furnished by them in their online application, overall Rank obtained by them in the Written Examination and with reference to the rule of reservation of appointments and No. of vacancies.
3. The admission of candidates to Original Certificate Verification and counseling is provisional subject to verification and acceptance of their claim in their online applications such as Age, Educational Qualification, Community, PSTM etc., through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Original Certificate Verification and Counseling will be cancelled and they will not be admitted to the next stage of selection.
4. The candidates who have appeared for Written Examination on 07.04.2019 FN & AN to the Post of Assistant Agricultural Officer (2016 – 2019) and Assistant Agricultural Officer (Shortfall vacancies for ST candidates only) in the Tamil Nadu Agricultural Extension Subordinate Service and whose Register Numbers are not found in the above list have not been admitted to the Certificate Verification / Counseling for the said post.

5. After verification of Original Certificates, the eligible candidates alone are admitted for Counselling to be held on the same day itself.
6. Candidates can download their notice for admission to Certificate Verification and Counselling from the Commission's Website and should attend the Certificate Verification/Counselling with the relevant documents in Original on the prescribed Date and Time without fail. Candidates who have failed to attend Certificate Verification and Counselling in the Scheduled Date/time will not be considered for the next stage of selection.
7. Candidates who have been admitted for Original Certificate Verification and Counselling are hereby advised to watch daily the commission's website regarding availability of Vacancies which has been hosted in the Commission's website. The provisional admission of candidates to Original Certificate Verification and Counselling does not confer any right for selection and their selection will be, subject to availability of vacancies in their respective reservation categories, when they reach their turn as per their rank position, since the candidates are summoned for Original Certificate Verification/ Counselling in the ratio of 1:1.5
8. The admission of candidates for Certificate Verification and Counselling is purely provisional subject to the outcome of OAs/WPs, if any pending of the files of the Hon'ble High Court of Madras/Madurai Bench of Madras High Court relating to this recruitment.
9. The Candidates summoned for the Original Certificate Verification and Counselling are not assured of selection.
