Candidates who have been admitted for Online Certificate Verification are hereby advised to watch constantly the Commission's webiste regarding mode, place, date and time of certificate verification without fail. Failure to produce even any one of the essential documents will result in their non-admission to the next stage of selection.
- 6. The Candidates admitted for Online Certificate Verification are not assured to be admitted for next stage of selection.
