In the letter first cited, the Registrar,  
Annamalai University, has requested the Government  
to recognise the degree courses of Master of Business  
Studies, Master of Financial Studies and M.A. American  
Studies, for the purpose of Higher Education and  
appointment in Public Service.

2. The Secretary, Tamil Nadu Public Service  
Commission, was requested by the Government to place the  
above subject, before the Committee constituted in the  
G.O.Ms.No.441, Personnel and Administrative Reforms (R)  
Department, dated 20.12.93 under the Chairmanship of  
Chairman, Tamil Nadu Public Service Commission.

3. In the letter third cited, the Secretary,  
Tamil Nadu Public Service Commission, has stated that  
the request of the Registrar, Annamalai University,

for recognition of the following new degree courses offered by their University for the purpose of employment opportunity was placed before the Committee in its meeting held on 21.9.99 :

1. Master of Business Studies.
2. Master of Financial Studies.
3. M.A. American Studies.

It was resolved by the Committee in conformity with its decision already taken in the meeting held on 3.1.96 that there is no need to get the recommendation of the Committee for recognising the Degrees and Diplomas offered by the Universities recognised by the University Grants Commission, for purpose of its grant and that it goes without saying that all such degrees and diplomas are automatically stand recognised.

4. Therefore, I am directed to state that the degree courses, viz., (1) Master of Business Studies, (2) Master of Financial Studies, (3) M.A. American Studies offered by Annamalai University will be automatically recognised for the purpose of employment.
