The candidate with the following Register Number is admitted to Certificate Verification and Counselling and his/her admission to Certificate Verification and Counselling is purely provisional subject to verification and acceptance of the documents in support of the claims made in his/her online application in respect of Age, Communal category, PSTM, Educational Qualification etc., Only after verification of the claims with the original certificates, his/her eligibility will become final for admission to Counselling. If he/she does not produce the required certificates or if he/she does not satisfy the eligibility

criteria, his/her online application will be rejected and his/her provisional admission to Counselling will be cancelled

Notes:-

1. Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for Original Certificate Verification and Counselling.
2. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Original Certificate Verification and Counselling based on the particulars furnished by them in their online application, **documents not uploaded by the candidates through e-Seva Centres**, overall Rank/Marks obtained by them in the Written Examination and with reference to the Rule of reservation of appointments and Number of vacancies.
3. The admission of candidates to Original Certificate Verification and Counselling is provisional subject to verification and acceptance of their claim in their online applications such as Age, Gender, Educational Qualification, Community, PSTM, etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Original Certificate Verification will be cancelled and they will not be admitted to Counselling.
4. The candidates who have appeared for written examination on 01.09.2019 F.N. to the **POSTS OF JUNIOR ASSISTANT / FIELD SURVEYOR / VILLAGE ADMINISTRATIVE OFFICER INCLUDED IN COMBINED CIVIL SERVICES EXAMINATION – IV (GROUP-IV SERVICES), FOR THE YEARS 2018-2019 AND 2019-2020** and whose Register Numbers are not found in the above list have not been admitted to the Original Certificate Verification and Counselling for the said posts in phase - III.
5. After verification of original certificates, the eligible candidates alone are admitted for Counselling to be held on the same day itself.
6. Candidates can download their Notice for Admission to Original Certificate Verification and Counselling from the Commission's Website and should attend the Original Certificate Verification and Counselling with all relevant documents in Original, on the prescribed Date and Time without fail. Candidates who have failed to attend Certificate Verification

and Counselling on the scheduled Date and Time will not be considered for the next stage of selection.

7. The admission of candidates for Original Certificate Verification and Counselling is purely provisional, subject to the outcome of OAs/WPs if any, pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court and the Supreme Court of India relating to this recruitment.
8. The candidates summoned for the Original Certificate Verification and Counselling are not assured of Selection.
