The candidates who have appeared for Written Examination on 11.02.2018 FN to the **TYPIST GR.III INCLUDED IN COMBINED CIVIL SERVICES EXAMINATION-IV FOR THE YEARS (GROUP-IV) YEARS 2015-2016, 2016-2017 AND 2017-2018(II PHASE)** and whose register numbers are not found in the above list have not been admitted to the Certificate Verification for the said post.
4. The admission of the above candidates to the Certificate Verification is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.

Candidates who have been admitted for Certificate Verification are hereby advised to watch constantly the Commission's website regarding mode, place, date and time of certificate verification without fail. Failure to produce even any one of the essential document will result in their non-admission to the next stage of selection.
