## Note:-

- 1. First, the selection will be made for the carried forward vacancies if any arises in the previous recruitment. [Section 27 of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016]
- 2. Secondly, the selection will be made for regular vacancies following the rule of reservation.
- 3. Thirdly, the selection against shortfall vacancies will be made from among SC/SCA/ST applicants only.
- 4. The reservation for Women, Ex-serviceman and Differently Abled Persons will not be applicable for the recruitment of shortfall vacancies. [Section 27(h) of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016].
- 5. All the other details/conditions stipulated in the Notification No.10/2017, dated 27.04.2017 will remain unchanged and will apply to the candidates.
