# POSTS INCLUDED IN TAMIL NADU APPROVED SCHOOLS AND VIGILANCE SERVICE, TAMIL NADU JAIL SERVICE AND TAMIL NADU GENERAL SERVICE (2015 - 2017)

Two lists of candidates admitted provisionally to Certificate Verification for the **POSTS INCLUDED IN TAMIL NADU APPROVED SCHOOLS AND VIGILANCE SERVICE, TAMIL NADU JAIL SERVICE AND TAMIL NADU GENERAL SERVICE (2015 - 2017)** were published in the Commission's website on 02.08.2017 and 06.12.2017 based on the results of the written examination conducted by the Commission on 25.02.2017 FN and 26.02.2017 FN & AN.

2 candidates were absent and the applications of 6 candidates were rejected during the 1<sup>st</sup> and 2<sup>nd</sup> phases of Certificate Verification held 17.08.2017 and 19.12.2017 respectively. After the 1<sup>st</sup> and 2<sup>nd</sup> phases of Certificate Verification, it has been decided to admit the candidates to Oral Test as the candidates are available in the required ratio for the post of Superintendent of Approved Schools for Boys (Now Government Children Home for Boys) in the Tamil Nadu Approved Schools and Vigilance Service, 2015-2016. However in respect of the post of Psychologist in Government Institute for Mentally Retarded, Tambaram in the Tamil Nadu General Service, 2015-2016, as the candidates are not available in the required ratio it has been decided to admit the candidates to 3<sup>rd</sup> phase of CV at the ratio of 1:5.

Accordingly, the candidates with the following Register Numbers have been provisionally admitted to Oral Test for the post of Superintendent of Approved Schools for Boys (Now Government Children Home for Boys) in the Tamil Nadu Approved Schools and Vigilance Service, 2015-2016.

The Oral Test will be held on <u>04.04.2018</u> and Certificate Verification will be held on <u>27.03.2018</u>, at the office of the Tamil Nadu Public Service Commission, TNPSC Road, Chennai - 600 003. The candidates should come to office of the Tamil Nadu Public Service Commission with all original certificates in support of the claims made in their online applications. Individual intimation regarding the date and time of the Oral Test and Certificate Verification will be sent to the candidates separately.

### Notes:

- 1. Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for Certificate Verification / Oral Test.
- 2. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Certificate Verification / Oral Test based on the marks obtained by them in the Written Examination and with reference to the rule of reservation of appointments. The admission of candidates to Certificate Verification / Oral Test is provisional subject to verification and acceptance of the claim in their online applications towards Age, Educational Qualification, PSTM, Experience/Training etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Certificate Verification / Oral Test will be cancelled and they will not be admitted to the next stage of selection.
- 3. The candidates who have appeared for Written Examination on 25.02.2017 FN for the post of Superintendent of Approved Schools for Boys (Now Government Children Home for Boys) in the Tamil Nadu Approved Schools and Vigilance Service, 2015-2016 and whose register numbers are not found in the above list have not been admitted to the Oral Test for the said post.
- 4. The admission of the above candidates to the Certificate Verification / Oral Test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.
- 5. Candidates who have been admitted Certificate Verification / provisionally to the Oral Test are hereby advised to attend the Oral Test with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the next stage of selection / Oral Test.
