The lists of Register Numbers of candidates admitted provisionally to Oral Tests (Phase – I & Phase – II) for the Post of **JUNIOR SCIENTIFIC OFFICER in Forensic Sciences Department in the Tamil Nadu Forensic Science Subordinate Service, 2015-2019** were published in the Commission's Website on 25.02.2021 & 25.01.2022 respectively based on the results of the Written Examination conducted by the Commission on **24.08.2019 FN & AN**.

During the 1<sup>st,</sup> 2<sup>nd</sup> and 3<sup>rd</sup> phases of counselling, out of the 72 vacancies notified, 71 vacancies had been filled and the remaining **O1 vacancy for Physics & Chemistry group (Division: Computer Forensic Science)** has not been filled up due to non – availability of eligible candidates in the respective group / category for the said post. Hence, it has been decided to admit the candidates to the next phase of Certificate Verification (Phase – IV) against the 01 unfilled vacancy.

Hence, the candidates with the following register numbers are hereby admitted provisionally to the IV phase of certificate verification. The candidates who have been admitted provisionally to the IV phase of Certificate Verification should upload the scanned copy of documents in support of the claims made in their online application from <u>29.03.2022</u> to <u>06.04.2022</u> in the e-seva centres run by TACTV. List of designated e-seva centres is available in the website. The details regarding the documents to be uploaded will be made available in the Commission's Website and candidates will be informed of the above fact only through SMS and e-mail. Individual communication in this regard will NOT be sent to the candidates by post.

- 1. Mere inclusion of the Register Numbers of candidates in the above list will not imply that the candidature has been fully considered for next stage of selection.
- 2. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the IV phase of Certificate Verification based on the marks obtained by them in the Written Examination and with reference to the Rule of Reservation of appointments.
- 3. The admission of the candidates to Certificate Verification is provisional subject to verification and acceptance of the claim made in their online applications towards Age, Educational Qualification, Communal Category, PSTM, etc., through original documents. If any of their claims are found to be false or incorrect, their online applications will be rejected, their provisional admission to Certificate Verification will be cancelled and they will not be admitted to the next stage of selection.
- 4. The admission of the above candidates to the Certificate Verification is purely provisional subject to the decision of the

Commission and subject to the outcome of final orders to be passed by the Hon'ble High Court of Judicature at Madras in the W.P.No.29950 of 2019 and other cases relating to this recruitment, if any, pending on the files of the Hon'ble High Court, Madras / Madurai Bench of Madras High Court.

5. Candidates who have been admitted provisionally to the IV phase of Certificate Verification are hereby advised to upload the scanned copy of all the relevant documents without fail. Failure to upload even any one of the essential documents within the time limit stipulated above will result in their non-admission to the next stage of selection and rejection of their online application.
