The list of candidates provisionally admitted to certificate verification for Oral Test for appointment by direct recruitment to the post of **JUNIOR SCIENTIFIC OFFICER IN THE TAMIL NADU FORENSIC SCIENCES SUBORDINATE SERVICE (2013 - 2015),** based on results of the written examination conducted by the Tamil Nadu Public Service Commission on 16.10.2016 FN & AN was published on 24.04.2017. In order to adhere to the ratio of 1:2/1:3 for admission to Oral Test, it has been decided by the Commission to substitute candidates in the place of absentees and ineligible candidates. During Certificate Verification held on 05.05.2017, 4 candidates have absented themselves, the eligibility of 6 candidates has changed and the applications of 4 candidates have been subsequently rejected.

- 1. Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for Oral Test.
