The list of candidates provisionally admitted to certificate verification to find out their eligibility for Oral Test for appointment by direct recruitment to the post of **ASSISTANT JAILOR IN PRISON DEPARTMENT IN THE TAMIL NADU JAIL SUBORDINATE SERVICE (1996-2010),** based on results of the written examination conducted by the Tamil Nadu Public Service Commission on 24.07.2016 FN & AN was published on 26.04.2017. In order to adhere to the ratio of 1:2/1:3 for admission to Oral Test, it has been decided by the Commission to substitute candidates in the place of absentees and ineligible candidates. During Certificate Verification held on 01.06.2017 and 02.06.2017, 41 candidates have absented themselves, the eligibility of 1 candidate has changed and the applications of 8 candidates have been subsequently rejected.

Hence, apart from the candidates who had already completed the certificate verification and found eligible, the candidates with the following register numbers are hereby admitted provisionally to the certificate verification for oral test. The certificate verification will be held on **26.07.2017**, at the office of the Tamil Nadu Public Service Commission, Frazer Bridge Road, Chennai – 600 003. The admission of the above candidates to the Certificate Verification is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WP No. 15981 of 2016 and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment
- 4. Candidates who have been admitted provisionally to the Certificate Verification are hereby advised to attend the Certificate Verification with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the next stage of selection.
