

ASSISTANT JAILOR IN PRISON DEPARTMENT IN THE TAMIL NADU JAIL SUBORDINATE SERVICE (1996-2010)

Lists of Register number of candidates provisionally admitted to Certificate Verification to find out their eligibility for Oral Test for appointment by direct recruitment to the post of ASSISTANT JAILOR IN PRISON DEPARTMENT IN THE TAMIL NADU JAIL SUBORDINATE SERVICE (1996-2010), were published in the Commission's website on 26.04.2017, 13.07.2017 and 23.08.2017 based on the results of the written examination conducted by the Commission on 24.07.2016 FN & AN.

During the 1st phase of Certificate Verification held on 01.06.2017/02.06.2017,41 candidates were absent, applications of 7 candidates have been subsequently rejected and status of 1 candidate has changed. During 2nd phase of Certificate Verification held on 26.07.2017, 15 candidates were absent. During the 3rd phase of Certificate Verification held on 06.09.2017, 12 candidates were absent, application of 1 candidate has been subsequently rejected and status of 4 candidates has changed. It has therefore been decided by the Commission to admit the candidates in the place of absent and ineligible to the next phase of Certificate Verification in the ratio of 1:3.

Hence, apart from the candidates who had already completed the certificate verification, the candidates with the following register numbers are hereby admitted provisionally to the certificate verification for the said post. The certificate verification will be held on <u>11.10.2017</u>, at the office of the Tamil Nadu Public Service Commission, Frazer Bridge Road, Chennai – 600 003. - 2. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Certificate Verification to find out their eligibility for admission to Oral Test based on the marks obtained by them in the Written Examination and with reference to rule of reservation of appointments. The admission of candidates to Certificate Verification is provisional subject to verification and acceptance of the claim in their online applications towards Age, Educational Qualification, Community, PSTM, Ex-servicemen, Experience etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Certificate Verification will be cancelled and they will not be admitted to next stage of selection.

The admission of the above candidates to the Certificate Verification is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WP No. 15981 of 2016 and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment

4. Candidates who have been admitted provisionally to the Certificate Verification are hereby advised to attend the Certificate Verification with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the next stage of selection.
