Candidates who have failed to attend physical Certificate Verification / Counselling on the scheduled date and time will not be considered for the next stage of selection.

The Provisional admission of the candidates to Physical Certificate Verification and Counseling does not confer any right for selection and their selection will also be subject to availability of vacancies in ir respective reservation categories, when they reach their turn as per their rank position and they are not assured of their selection.
