If any of their claims are found to be false or incorrect, their provisional admission to Oral Test will be cancelled and they will not be admitted to the next stage of selection.
- 5. The admission of the above candidates to the Oral Test is purely provisional subject to the decision of the Commission and

subject to the outcome or final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases relating to this recruitment, if any, pending on the files of the Hon'ble High Court, Madras / Madurai Bench of Madras High Court.

- 6. Candidates who have been admitted provisionally to the Oral Test are hereby advised to attend Oral Test with all the relevant documents without fail. Failure to produce even any one of the essential documents will result in their non-admission to the Oral Test.
- 7. The list of register numbers of candidates who were admitted to Certificate Verification and who have not been considered for provisional admission to Oral Test and the reasons therefor have been mentioned in the Annexure to this list.
