

## DRAUGHTSMAN, GRADE-III IN THE TOWN AND COUNTRY PLANNING DEPARTMENT IN THE TAMIL NADU TOWN AND COUNTRY PLANNING SUBORDINATE SERVICE (2017-2018) List-OT

The admission of the above candidates to the Oral Test is purely provisional subject to the decision of the Commission and subject to the outcome or final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases relating to this recruitment, if any, pending on the files of the Hon'ble High Court, Madras / Madurai Bench of Madras High Court.
- 6. Candidates who have been admitted provisionally to the Oral Test are hereby advised to attend the Oral Test with all the relevant documents without fail. Failure to produce even any one of the essential document will result in their non-admission to Oral Test.
