Two lists of candidates provisionally admitted to Certificate Verification for the post of Executive Officer, Grade-III in the Tamil Nadu Hindu Religious and Charitable Endowments Subordinate Service included in Group- VII- B Services (2014-2015, 2015-2016 & 2016-2017) was published in the Commission's website on 09.11.2017 and 04.12.2017 based on the results of the written examination conducted by the Commission on 10.06.2017 FN & AN.

During the 1st phase of Certificate Verification held on 20.11.2017 and the 2nd phase of Certificate Verification held on 15.12.2017, the applications of 6 candidates were rejected and 7 candidates were absent.

After the 1st and 2nd phases of Certificate Verification, the candidates whose register numbers are mentioned below have been provisionally admitted to Oral Test in the ratio of 1:2/1:3. The Oral Test will be held on **<u>19.01.2018</u>**, at the office of the Tamil Nadu Public Service Commission, Frazer Bridge Road, Chennai – 600 003. The candidates should come to office of the Tamil Nadu Public Service Commission with all original certificates in support of the claims made in their online applications. The admission of the above candidates to the Oral Test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.

- 5. Candidates who have been admitted provisionally to the Oral Test are hereby advised to attend the Oral Test with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to Oral Test.
- 6. The list of register numbers of candidates who were absent, whose applications were rejected, who were found ineligible after the 1st and 2nd phases of Certificate Verification and who have not reached the zone of consideration for provisional admission to Oral Test have been mentioned in the Annexure to this list.
