

POST OF JAILOR IN THE TAMIL NADU JAIL SERVICE (2013 - 2015)

Two lists of candidates admitted provisionally to Certificate Verification for the post of **JAILOR IN THE TAMIL NADU JAIL SERVICE** (2013 - 2015), were published in the Commission's website on 11.08.2017 and 18.09.2017 based on the results of the written examination conducted by the Commission on 15.04.2017 FN & AN.

During the 1st Phase of Certificate Verification held on 30.08.2017, 4 candidates were absent. It had therefore been decided by the Commission to admit the candidates to the 2nd phase of Certificate Verification at the ratio of 1:5. During the 2nd Phase of Certificate Verification held on 26.09.2017, 2 candidates were absent.

After the 1st and 2nd Phases of Certificate Verification, the candidates whose Register Numbers are mentioned below have been provisionally admitted to Oral Test in the ratio of 1:3. The Oral Test will be held on 27.10.2017, at the office of the Tamil Nadu Public Service Commission, Frazer Bridge Road, Chennai - 600 003. The candidates should come to office of the Tamil Nadu Public Service Commission with all original certificates in support of the claims made in their online applications. - Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for Oral Test.

The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Oral Test based on the marks obtained by them in the Written Examination and with reference to the rule of reservation of appointments. The admission of candidates to Oral Test is provisional subject to verification and acceptance of the claim in their online applications towards Age, Educational Qualification, PSTM etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Oral Test will be cancelled.
- 3. The candidates who have appeared for Written Examination on 15.04.2017 FN & AN and whose register numbers are not found in the above list have not been admitted to the Oral Test.
- 4. The admission of the above candidates to the Oral Test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.

- 5. Candidates who have been admitted provisionally to the Oral Test are hereby advised to attend the Oral Test with all the relevant documents in original, without fail. If any one of the essential document is not produced their provisional admission to Oral Test will be cancelled.
- 6. The list of register numbers of candidates who were absent and who have not reached the zone of consideration for provisional admission to Oral Test have been mentioned in the Annexure to this list.
