3. Under what penal provisions would you prosecute the offenders in the following cases:

- (a) 'A' intentionally causes Z's death, partly by illegally omitting to give Z food, and partly by beating Z. State the offence committed by 'A'.
- (b) 'A' a soldier fires on a mob by the order of his superior officer in conformity with the commands of Law. What offence, is 'A' guilty of?
- (c) 'A' instigates 'B' to murder 'C'. 'B' refuses to do so. Has 'A' committed any offence?
- (d) 'A' makes a false entry in his shop-book for the purpose of using it as corroborative evidence in a court of Justice. Is 'A' guilty of any offence?
- (e) 'A' being Z's servant and entrusted by Z with the care of Z's plate, dishonestly runs away with the plate, without Z's consent. Has 'A' committed any offence?

7. Answer the following giving Sections of Law :

- (a) 'A' for the purpose of inducing 'B' to desist from prosecuting a civil suit, threatens to burn B's house. Is 'A' guilty of any offence?
- (b) 'A' makes an attempt to pick the pocket of Z by thrusting his hand into Z's pocket. A fails in the attempt in consequence of Z's having nothing in his pocket. Is 'A' guilty of any offence?
- (c) 'A' signs his own name to a bill of exchange intending that it may be believed that the bill was drawn by another person of the same name. Has 'A' committed any offence?
- (d) 'Z' is standing in his doorway. 'A' forces a passage by knocking 'Z' down and commits house trespass by entering the house. State the nature of offence.
- (e) 'A' voluntarily throws into a river a ring belonging to 'Z' with the intention of thereby causing wrongful loss to 'Z'. What offence has 'A' committed?
- (f) 'A' by pledging as diamonds articles which he knows are not diamonds, intentionally deceives 'Z' and thereby dishonestly induces 'Z' to lend money. What offence is 'a' guilty of?
- (g) 'A' a carrier, is entrusted by 'Z' with property to be carried by land or by water. 'A' dishonestly misappropriates the property. What offence has 'A' committed?
- (h) 'A' finds a valuable ring not knowing to whom it belongs. 'A' sells it immediately without attempting to discover the owner. Has 'A' committed any offence?
- (i) 'A' in India instigates B, a foreigner in Goa, to commit a murder in Goa. What offence is 'A' guilty of?
- (j) 'A' attacks Z under such circumstances of grave provocation that his killing of Z would be only culpable homicide not amounting to murder, 'B' having illwill towards 'Z' and intending to kill him and not having been subject to the provocation assists 'A' in killing 'Z'. What offence is 'A' guilty of?
