 - (iii) Degree Certificates and Mark Statements
3. **Evidence of qualification in Tamil:** SSLC / PUC / HSC /Degree in the case of candidates who have passed the said examination(s) with Tamil as one of the languages (or) Evidence for having passed the Second Class Language Test (Full Test) in Tamil & PSTM Certificate if claimed PSTM Reservation.
4. **Community Certificate:** Community Certificate from the competent Revenue authority as specified in para 15 (f) of the Commission's '**Instructions to candidates**'.
5. **Evidence for Religion:** Community Certificate / Transfer Certificate.
6. **Last Studied Conduct Certificate:** Certificate of character and conduct obtained from the Head of Institution in which he / she last studied / studying.
7. **Latest Conduct Certificate** obtained from a Government officer belonging to Group A or Group B duly mentioning his / her name, father's name, address and period during he / she is known to the Government officer (Minimum 2 years).
8. **Photographs:** Three copies of recent passport size photographs.
