



**POST OF EXECUTIVE OFFICER, GRADE-IV INCLUDED IN GROUP-VIII SERVICES IN  
TAMIL NADU HINDU RELIGIOUS AND CHARITABLE ENDOWMENTS SUBORDINATE  
SERVICE**

The candidates with the following register numbers have been admitted to Physical Certificate Verification and his/her admission to Certificate Verification is purely provisional subject to verification and acceptance of the documents in support of the claims made in his/her online application in respect of Age, Gender, Communal Category, Persons Studied in Tamil Medium, Educational Qualification, Experience, etc. Only after verification of the claims with the original certificates, his/her eligibility will become final for admission to further selection process. If he/she does not produce the required certificates or if he/she does not satisfy the eligibility criteria, his/her online application will be rejected and his/her provisional admission to Physical Certificate Verification will be cancelled.

6. The provisional admission of the candidates to Physical Certificate Verification does not confer any right for selection and their selection will also be subject to availability of vacancies in their respective reservation categories and they are not assured of their selection.
7. The admission of above candidates for Physical Certificate Verification is purely provisional subject to final orders to be passed in W.A. (MD) No.181 of 2023 and CMP (MD) 2247 of 2023 pending before the Hon'ble High Court and other cases, if any, pending on the files of the Hon'ble High Court of Madras / Madurai Bench of Madras High Court relating to this recruitment.
