Two lists of candidates provisionally admitted to Certificate Verification for the post of **Statistical Inspector in the Tamil Nadu Animal Husbandry Subordinate Service** was published in the Commission's website on 30.01.2019 & 13.02.2019 based on the results of the written examination conducted by the Commission on 23.12.2018 FN & AN.

The candidates were asked to attend Certificate Verification for 1st phase of Certificate Verification on 07.02.2019 and 2nd phase of certificate Verification on 19.02.2019 with all original documents in support of the claims made in their online applications. Based on the outcome of the Certificate Verification(s), the candidates whose Register Numbers are mentioned below have been provisionally admitted to Oral Test in the ratio of 1:3. The Oral Test will be held on **15.03.2019**, at the office of the Tamil Nadu Public Service Commission, TNPSC Road, Chennai - 600 003. The admission of the above candidates to the oral test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.
5. Candidates who have been admitted provisionally to the oral test are hereby advised to attend the oral test with all the relevant documents in original, without fail. Failure to produce even any one of the essential documents will result in their non-admission to the next stage of selection.
