**Block Health Statistician in the Family Welfare Department in the
Tamil Nadu Medical Subordinate Service (2007-2011)**

A list-I of 343 candidates provisionally admitted to Certificate Verification for Oral Test for appointment by direct recruitment to the post of **Block Health Statistician in the Family Welfare Department in the Tamil Nadu Medical Subordinate Service (2007-2011)** was published in the Commission's website on 21.12.2016 based on the results of the written examination conducted by the Commission on 05.06.2016 FN & AN.

During the 1st Phase of Certificate Verification held from 04.01.2017 to 06.01.2017, 49 candidates had absented themselves, the applications of 6 candidates have been subsequently rejected, community status of 1 candidate has been changed and 1 candidate has been considered under Non Ex-serviceman category. It had been decided by the Commission to admit the candidates to the 2nd phase of Certificate Verification at the ratio of 1:3. Hence, apart from the candidates who had already completed the certificate verification and found eligible, List-II of 223 candidates were provisionally admitted to next phase of Certificate Verification.

During the 2nd Phase of Certificate Verification held on 14.02.2017 and 15.02.2017, 25 candidates mentioned in the Annexure had absented themselves and 4 candidates mentioned in the Annexure were found ineligible for the said post.

Hence, after the 1st Phase and 2nd Phase of Certificate Verification, the candidates whose Register Numbers are mentioned below have been provisionally admitted to Oral Test in the ratio of 1:2/1:3. The Oral Test will be held from **15.05.2017** to **19.05.2017**, at the office of the Tamil Nadu Public Service Commission, Frazer Bridge Road, Chennai – 600 003. The candidates should come to office of the Tamil Nadu Public Service Commission with all

original certificates in support of the claims made in their online applications. Individual intimation regarding the date and time of the Oral Test will be sent to the candidates separately:-

2. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Oral Test based on the marks obtained by them in the Written Examination and with reference to the rule of reservation of appointments. The admission of candidates to Oral Test is provisional subject to verification and acceptance of the claim in their online applications towards Age, Educational Qualification, Community, PSTM, Ex-servicemen, Destitute widow, Differently Abled status etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Oral Test will be cancelled and they will not be admitted to the Oral Test.
3. The candidates who have appeared for Written Examination on 05.06.2016 FN & AN and whose register numbers are not found in the above list have not been admitted to the Oral Test.
4. The admission of the above candidates to the Oral Test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.
5. Candidates who have been admitted provisionally to the Oral Test are hereby advised to attend the Oral Test with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the Oral Test.
