ORDER:

In the Government order first cited, orders were issued for the constitution of Departmental Promotion Committees. In the Government order second cited, among other things, it has been ordered that a member belonging to Scheduled Caste / Scheduled Tribe should be included in the Departmental Promotion Committees for selection of candidates to the posts where rule of reservation is applied at the stage of promotion.

2) At present, rule of reservation is followed at the stage of promotion in the following eight services.

STATE SERVICE

- i) Tamil Nadu Civil Services (Executive Branch),
- ii) Tamil Nadu Highways Engineers Service,
- iii) Tamil Nadu Survey and Land Records Service,
- iv) Tamil Nadu Subordinate Civil Judicial Service,
- v) Tamil Nadu Commercial Taxes Service,

SUBORDINATE SERVICE

- vi) Deputy Tahsildars in Tamil Nadu Revenue Subordinate Service,
- vii) Assistant Commercial Tax Officer, Tamil Nadu Commercial Taxes Subordinate Service and
- viii) Sub-Registrar, Grade II in Tamil Nadu Registration Subordinate Service.

3) Accordingly, Government direct that a Group-A Officer of the Department belonging to Scheduled Caste / Scheduled Tribe, be included as a Member of that department's Departmental Promotion Committee for selection of Candidates for appointment by recruitment by transfer or by promotion to various posts to which the rule of reservation is applicable. If the nominated officer is himself included in the panel for consideration or when no Scheduled Caste / Scheduled Tribe officers are available in Group-A, Government direct that the senior-most Group-B Officer be nominated to the Departmental Promotion Committee.

4) The Scheduled Caste / Scheduled Tribe member nominated to the Departmental Promotion Committee should submit reports on the following aspects to the nodal officer of the Administrative Department in Secretariat, Secretary, Personnel and Administrative Reforms Department and Secretary, Adi Dravidar and Tribal Welfare Department, after attending each meeting.

- a) Was rotation followed correctly ?
- b) Whether sufficient Scheduled Caste / Scheduled Tribe candidates have been listed? If not, what is the reason ?
- c) Whether any charges have been levelled against Scheduled Caste / Scheduled Tribe persons who have come under the zone of consideration within a period of one year prior to the crucial date.

5) The above instructions shall be followed scrupulously by all the panel drawing authorities while selecting candidates for appointment to the posts where rule of reservation is applied at the stage of promotion.
