### Notes :

1. The candidates whose Register numbers are found in the above list have been admitted provisionally to the Oral Test based on the marks obtained by them in the Competitive Examination and with reference to the rule of reservation of appointments. The admission of candidates to Oral Test is provisional subject to verification and acceptance of their claim in their applications towards age, educational qualification, community etc., through original documents. If any of their claims are found to be false or incorrect, they will not be admitted to the Oral Test.
2. The selection of the above candidates for admission to Oral Test is provisional subject to acceptance of certain documents, educational qualification possessed by him/her, clarification regarding community status and its acceptance etc., as the case may be.
3. The candidates who have appeared for the Written Examination and whose Register Numbers are not found in the above list have not been admitted to the Oral Test.

4. The selection of the candidates for admission to the Oral Test is purely provisional subject to the outcome of any cases/WPs relating to this recruitment if any, pending before the Hon'ble High Court of Judicature at Madras or at Madurai Bench of the Madras High Court.
