The list of register number of candidates admitted provisionally to Onscreen Certificate Verification in the ratio of 1:3/1:4 for the posts of **Agricultural Officer (Extension) and Assistant Director of Agriculture(Extension)** in Tamil Nadu Agricultural Extension Service and post of **Horticultural Officer** in Tamil Nadu Horticultural Service was published on the Commission's website on 13.10.2023 and 17.02.2024 based on the results of the examination (Computer Based Test) conducted by the Commission on 20.05.2023 and 21.05.2023 FN & AN.

Based on the outcome of Onscreen Certificate Verification (Phase-I and II), the register number of candidates mentioned below have been provisionally admitted to **Oral Test** in the ratio of 1:2/1:3 for the posts of Agricultural Officer (Extension) and Assistant Director of Agriculture(Extension) in Tamil Nadu Agricultural Extension Service and post of Horticultural Officer in Tamil Nadu Horticultural Service based on the marks obtained by the candidates in the said examination and other conditions stipulated in the notification for the said recruitment.

The Oral Test will be held from **20.05.2024 to 22.05.2024** at the office of the Tamil Nadu Public Service Commission, TNPSC Road, Chennai- 600 003. As per the Commission's list dated 17.02.2024 for Onscreen Certificate Verification (Phase-II), it had been announced that

29 candidates were not considered for the post of Assistant Director of Agriculture (Extension). Now, based on the direction of the Hon'ble High Court and clarification received from the Registrar, Tamil Nadu Agricultural University, 27 out of 29 candidates are eligible for the post of Assistant Director of Agriculture (Extension) in the said recruitment.

The candidates should attend the Oral Test with all original certificates in support of the claims made in their online application. The above details will be made available in the Commission's website and the candidates will be informed of the above fact only through SMS and e-mail. Individual communication regarding the date and time of Oral Test will not be sent to the candidates by post.
