Any representation from the candidates for non-receipt of SMS or e-mail will receive no attention.

- The candidates whose register number is found in the above list has been provisionally admitted to Oral Test based on the marks obtained by them in the Written Examination and with reference to the rule of reservation of appointments.

The admission of candidates to the Oral Test is provisional subject to verification and acceptance of the claims as made in their respective online application with regard to Age, Educational Qualification, Experience, Community, Differently Abled category, PSTM status etc., through original documents. If any of the claim of the candidates is found to be false or incorrect, their provisional admission to the Oral Test will be cancelled and they will not be admitted to the next stage of selection.
