The admission of the candidates to the Oral Test is provisional subject to the verification and acceptance of the claim in their online applications towards Age, Educational Qualification, Communal Category, Experience, etc., through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Oral Test will be cancelled and they will not be admitted to the next stage of selection.
4. The candidates who have appeared for Written Examination and whose register numbers are not found in the above list have not been admitted to the Oral Test.
