1. Mere inclusion of the Register Numbers of candidates will not imply that his/her candidature has been fully considered for Oral Test.
2. The candidates whose Register Numbers are found in the above list have been admitted provisionally to the Oral Test based on the marks obtained by them in the Computer Based Test , Educational Qualification possessed by them and Experience claimed by them and with reference to the rule of

reservation of appointments. The admission of candidates to Oral Test is provisional subject to verification and acceptance of their claim in their online applications towards age, educational qualification, religion, community through original documents and subject to verification of the Genuiness of the Experience Certificate. If any of their claims are found to be false or incorrect, their provisional admission to Oral Test will be cancelled and they will not be admitted to Oral Test.

3. The candidates who have appeared for the Computer Based Test and whose register numbers are not found in the above list have not been admitted to the Oral Test.

The admission of the above candidates to the Oral Test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and any other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court relating to this recruitment.
