The admission of the candidates to Physical Test is provisional subject to verification and acceptance of the claims in their online applications towards Age, Educational Qualification, Physical Qualification, Community, PSTM etc., through original documents. If any of their claims are found to be false or incorrect, they will not be admitted to the next stage of selection.
4. The Candidates who have appeared for the Written Examination and whose register numbers are not found in the above list have not been admitted to the Physical Test.
5. The admission of the candidates to the Physical Test is purely provisional subject to the decision of the Commission and subject to the outcome/final orders to be passed by the Hon'ble High Court of Judicature at Madras and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.
6. Candidates who have been admitted provisionally to the Physical Test are hereby advised to attend the Physical Test without fail. Only those who qualify in the Physical Test will be considered for admission to Certificate Verification for Oral Test.
