



**Assistant Director of Handloom and Textiles in the Tamil Nadu Handlooms and Textiles Service (2007-2008, 2010-2011, 2012-2013 & 2015-2016)**

A list of 42 candidates provisionally admitted to Certificate Verification for Oral Test for appointment by direct recruitment to the post of **Assistant Director of Handloom and Textiles in the Tamil Nadu Handlooms and Textiles Service (2007-2008, 2010-2011, 2012-2013 & 2015-2016)**, was published in the Commission's website on 11.08.2017 based on the results of the written examination conducted by the Commission on 08.04.2017 FN & AN.

During the 1<sup>st</sup> Phase of Certificate Verification held on 29.08.2017, the applications of 2 candidates have been subsequently rejected. It had been decided by the Commission to admit the candidates to the 2<sup>nd</sup> phase of Certificate Verification at the ratio of 1:3. Hence, apart from the candidates who had already completed the certificate verification and found eligible, List-II of 6 candidates were provisionally admitted to next phase of Certificate Verification for the above said post.

During the 2<sup>nd</sup> Phase of Certificate Verification held on 26.09.2017, 1 candidate had absented himself for the Certificate Verification.

After the 1<sup>st</sup> Phase and 2<sup>nd</sup> Phase of Certificate Verification, the candidates whose Register Numbers are mentioned below have been provisionally admitted to Oral Test in the ratio of 1:3. The Oral Test will be held on **26.10.2017**, at the office of the Tamil Nadu Public Service Commission, Frazer Bridge Road, Chennai – 600 003. **The candidates should come to office of the Tamil Nadu Public Service Commission**

the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and other cases pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court, if any, relating to this recruitment.

5. Candidates who have been admitted provisionally to the Oral Test are hereby advised to attend the Oral Test with all the relevant documents in original, without fail. Failure to produce even any one of the essential document will result in their non-admission to the Oral Test.
6. The list of Register numbers of candidates who were absent, whose applications were rejected and who have not reached the zone of consideration for provisional admission to Oral Test have been mentioned in the Annexure to this list.
