



Sub-Inspector of Fisheries (2013-2016) and Foreman (Marine) (2014-2015) in the Tamil Nadu Fisheries Subordinate Service

A list of 36 and 12 candidates provisionally admitted to Certificate Verification for Oral Test for appointment by direct recruitment to the post of **Sub-Inspector of Fisheries (2013-2016) and Foreman (Marine) (2014-2015)** respectively in the **Tamil Nadu Fisheries Subordinate service** was published in the Commission's website on 15.06.2017 based on the results of the written examination conducted by the Commission on 11.12.2016 FN & AN.

During the 1st Phase of Certificate Verification held on 30.06.2017, 3 candidates had absented themselves; the applications of 3 candidates have been subsequently rejected for the post Sub-Inspector of Fisheries and 2 candidates had absented themselves for the post of Foreman (Marine). It had been decided by the Commission to admit the candidates to the 2nd phase of Certificate Verification at the ratio of 1:5. Hence, apart from the candidates who had already completed the certificate verification and found eligible, List-II of 30 and 7 candidates were provisionally admitted to next phase of Certificate Verification for the above said posts.

During the 2nd Phase of Certificate Verification held on 28.07.2017, 1 candidate has absented himself and the application of 1 candidate has been subsequently rejected for the post Sub-Inspector of Fisheries and 2 candidates had absented themselves for the post of Foreman (Marine).

After the 1st Phase and 2nd Phase of Certificate Verification, the candidates whose Register Numbers are mentioned below have been provisionally admitted to Oral Test in the ratio of 1:3. The Oral Test will be held on **11.09.2017**, at the office of the Tamil Nadu Public Service Commission, Frazer Bridge Road, Chennai – 600 003. **The candidates should come to office of the Tamil Nadu Public Service Commission with all original certificates in support of the claims made in their online applications.
