marks obtained by them in the Written Examination, Educational Qualification possessed by them and with reference to the rule of reservation of appointments. The admission of candidates to Oral Test is provisional subject to verification and acceptance of their claim in their OMR applications towards Age, Educational Qualification, Community, PSTM etc, through original documents. If any of their claims are found to be false or incorrect, their provisional admission to Oral Test will be cancelled and they will not be admitted to Oral Test.

The admission of the above candidates to the Oral Test is purely provisional subject to the decision of the Commission and subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WPs and any other cases relating to this recruitment, if any, pending on the files of the Hon'ble High Court, Madras / Madurai Bench of Madras High Court.
4. **Candidates who have been admitted to the Oral Test are hereby advised to attend the Oral Test with all the relevant documents in original without fail. Failure to produce even any one of the essential documents will result in their non-admission to the Oral Test.**
