The list of Register number of candidates admitted provisionally to Onscreen Certificate Verification in the ratio of 1:3/1:4 for the posts of **Agricultural Officer (Extension), Assistant Director of Agriculture (Extension) included in the Tamil Nadu Agricultural Extension Service and Horticultural Officer included in the Tamil Nadu Horticultural Service** was published on the Commission's website on 13.10.2023 based on the results of the examination (Computer Based Test) conducted by the Commission on 20.05.2023 and 21.05.2023 FN & AN.

Based on the outcome of the Onscreen Certificate Verification (Phase-I), the application of 29 candidates who did not submit evidence for Equivalence of Qualification to the prescribed educational qualification had not been considered for Oral Test for the post of Assistant Director of Agriculture (Extension) in the said recruitment. The Commission shall not be responsible if the communication does not reach the applicant due to incorrect / invalid e-mail ID /mobile number and failure / delay in delivery of SMS / e-mail to the candidates due to any reason including technical issues. Any representation from the candidates for non-receipt of SMS or e-mail will receive no attention.

**NOTE:**

1. After Onscreen Certificate Verification (Phase-II), the list of eligible candidates for Oral Test for 3 posts in the said recruitment will be published subsequently in the ratio of 1:2/1:3.

2. **Mere inclusion of register number of a candidate does not imply that his /her candidature has been fully considered for next stage of selection.**

3. The candidates whose register number is found in the above list have been provisionally admitted to Onscreen Certificate Verification (Phase-II) based on the marks obtained by them in the examination (Computer based Test), rule of reservation of appointment and other conditions stipulated in the notification for the said recruitment.

4. The admission of candidates to Onscreen Certificate Verification (Phase-II) is provisional subject to verification and acceptance of claims as made in their online application with regard to Age, Educational Qualification, Communal category, Differently Abled category and PSTM status etc., through original documents. If any of the claims in the online application are found to be false or incorrect, their online application will be rejected and their provisional admission to Onscreen Certificate Verification (Phase-II) will be cancelled and they will not be admitted to the next stage of selection.

5. The admission of the above candidates to the Onscreen Certificate Verification(Phase-II) is purely provisional subject to the final orders to be passed in W.A.No.522/2022, W.P.(MD).No.10208/2023 and its batch cases,W.P.Nos.4933/2023, 15857/2023, 15868/2023, 33275/2023, 34608/2023, 34520/2023, W.A.(MD) No.181 of 2023 and CMP (MD) No.2247 of 2023 and others cases if any, pending on the files of the Hon'ble Supreme Court of India / Hon'ble High Court of Judicature at Madras / Madurai Bench of Madras High Court relating to this recruitment.
